resources. A discussion with key members of the Law Library and Administration took place resulting in a recommendation to amend the code of ethics for interpreters. Ms. Adams-Perlac's stance is that while it is right to utilize interpreters for sight translating in instances where the patron does not read English or Spanish, it may not be right to have interpreters fill out forms for the patron. There are concerns that interpreters are stepping out of their role when doing this. Ms. Adams-Perlac would like to give this committee an opportunity to consider the issue and offer an opinion before any policy changes are made. Given that there are many variables to consider, Judge Chon moved to table the topic until more information is available. Ms. Magagna seconded the motion; motion passed unanimously.
