Notes for discussion:

Clarification on Educational Requirements

There appears to have been a prior discussion about expanding the bachelor's degree path in the rules, but it was never formally codified. The current rules may be unclear. Rule 15-703 states that only paralegal associate and bachelor's degrees count toward the qualifications. However, the definition of "paralegal studies" in Rule 15-701 is broader, potentially allowing for a wider range of degrees to qualify. Based on older applications, some Licensed Paralegal Practitioners (LPPs) were approved under a more expansive interpretation beyond paralegal-specific degrees. I will review older iterations of the rules next week to clarify.

Clarification of the Roles and Responsibilities of the Steering Committee

I would like to clarify the Steering Committee's purpose, especially about the LPP Admissions Committee. Currently, the Admissions Committee has primarily focused on reviewing and approving applications and grading LPP exams. However, they should also discuss and approve any proposed rule changes related to the LPP admissions process and educational requirements. While the Steering Committee can still offer input and suggestions, the Admissions Committee should vote on whether to forward proposed rule changes to the Supreme Court for review.
