(1) Welcome and approval of minutes

Judge Mrazik welcomed members and guests to the meeting. Mr. Stormont moved to approved the minutes and Ms. Sudbury seconded. The motion carried.

(2) MyCase:

The committee, with Nathanael Player leading the discussion, discussed MyCase as follows:

MyCase allows litigants to view online case information. Case dockets are considered public. The software is ready to roll out but there has been no one to take the initiative. Judge Catherine Hoskins moved to support efforts to move MyCase forward. Mr. Stormont seconded. The motion carried. Could IT demonstrate the software for this committee in January with Kim Zimmerman's help?

(3) **Evictions:**

The committee, with input from multiple committee members, discussed evictions as follows:

The CDC evictions moratorium will end on December 31, 2020. Mr. Strand observed that the Litigation Section has been helping at the evictions calendars and asked whether that help should be ramped up. Mr. Player and Mr. Strand will talk offline to ensure solid coordination. Mr. Stormont said he would be willing to independently work on a "How to negotiate your way out of treble damages" guide that could be made available to housing advocates. Charles will talk with Senator Cullimore about what their clients are doing to keep people in their homes. He observed that there are not a lot of negotiations going on once a landlord is entitled to an order of restitution. Professor Francis asked whether pro bono counsel can be used. Committee members responded that there is not enough time within a 3-day time frame to get pro bono counsel involved. People's Legal Aid is calling litigants who have filed an answer and offering to represent them to help mitigate damages. Perhaps a Tuesday night bar special eviction program could be a possible solution?

Further discussion:

- Look at eviction diversion programs in other states.
- Can committee members see plaintiff attorneys' CDC eviction lists and connect the tenants with resources before the occupancy hearing?
- Legislation: Senators Kitchen, Harper worked together on affordable housing reforms last year. Harper works for Taylorsville City. Non-court committee members may reach out to them in their individual capacities to see if they are going to do anything on this topic in the upcoming session.
- Judge Mrazik said he would call Judge Parker and Jeff Daybell to get a feel for what they are seeing and what they expect to see.
- A sub-group needs to be formed to help organize some help. The Utah Housing Coalition does active lobbying on the hill. Nathanael will connect with them for information-gathering purposes to find out what they are planning. Sub-group: Leslie Francis, Sue Crismon, and Charles Stormont. Will meet next week. Rob Jepson said he would lend his new A2J attorney to help organize efforts. Nathanael Player, Judge Mrazik, and Nancy Sylvester will also join if they are able.

(4) Roundtable check-in on emerging issues related to COVID-19

Ms. Sudbury:

- Is connecting with clients more due to technology. She is also seeing an increase in client contact as a PGAL.
- She finds herself being more efficient. If a hearing takes 15 minutes, that's all she charges (no parking, commuting).

Shawn Newell:

- Would like to start some activities on outreach. Get feelers out with key community leaders to expand offerings of services. Beta test of reaching out to communities.
- He said he can lead out but needs content. Judge Mrazik supported the efforts and noted that we are still 1 year out on hiring an outreach coordinator.

Judge Hoskins:

 Access to justice is so much better with the tech roll out. Has made rural judges more accessible.

Sue Crismon:

- We need to compile a memorandum from this committee about what's working in 2020.
- Judge Hoskins will start working on the memo and getting feedback from justice court judges.
- Sue and Shawn will work on putting together an online outreach meeting every other month in 2021. Start in December with eviction information distribution. Shawn will pull this together. Judge Mrazik offered to be the face of this.
- CLE credit for pro bono work. Has things already in progress--voted on years ago by this committee. Board of District Court Judges will take this up 11/20.
