- 1. No quorum for approval of minutes
 - a. In October we will review the June and August minutes.
- 2. What we are seeing/concerns/observations re: self-represented litigants
 - a. REGARDING IN-PERSON/REMOTE HEARINGS
 - i. Self-reps appearing virtually, in-person and via hybrid
 - 1. Concerns re: presenting evidence
 - 2. Green phase work group is working on standards for remote or inperson hearings → there is not complete overlap between what is best for litigants and judges/court staff
 - ii. Some people seem relieved to be able to come into the courthouse and see people in-person communication can be easier when everyone is in the courtroom together
 - iii. Concerns regarding civility re: self-represented parties and remote hearings
 - iv. Self-reps don't have working emails so can't be served when people aren't appearing in-person
 - v. Concerns regarding people missing hearings and then defaulting
 - vi. Everyone is doing something different with regarding to how folks can access links for remote hearings
 - vii. Lawyers needing to appear in-person limits capacity to volunteer on pro se calendars
 - b. REGARDING THE DIGITAL DIVDE
 - i. Ongoing concerns regarding the digital divide people struggle to operate technology
 - ii. Webex is not used uniformly with the courts
 - 1. Breakout rooms note everyone does this, but it is helpful for lawyers to communicate with their clients/opposing parties
 - c. REGARDING ACCESS TO JUSTICE
 - i. People are unclear when and how to respond to pleadings they respond in ways that are incomplete or unhelpful
 - ii. People don't understand they need to respond to each document they receive
 - iii. People aren't sure how to fill out court forms
 - iv. People don't know about resources that are available
 - v. Big mistakes people don't answer complaints
 - vi. It is hard to find email addresses for filing
 - 1. Consider changing the link for finding the email address
 - d. There is a community center in San Juan County to help people with things like accessing the courts

- e. Lawyers are planning a name/gender change day, similar to an expungement day
- f. There is a lot of need for help with housing right now

3. Remote hearings

- a. Judges Mrazik and Torgerson advocate for judicial discretion, but for articulating factors to constrain discretion (such as prejudice to a party)
 - i. Guidelines that are too rigid are perhaps not helpful
- b. It is important to question all assumptions when we contemplate a policy decision
- c. Remote hearings can free up attorney capacity to allow them to volunteer remotely
 - i. Remote hearings bring volunteer capacity to remote areas where that kind of legal help was not available previously
 - ii. Lawyers who are unable to participate remotely are feeling somewhat devalued
- d. There should be clear explanations about how to use the technology and what is expected of parties
- e. Situations where a litigant is in-person but they have a pro bono lawyer who is remote what is best?
 - i. Arguably, having a remote attorney is better than no attorney
- 4. We will return to the question of navigators at our next meeting.
