- 1. Approval of minutes
 - a. October minutes were approved.
 - i. Nicole Gray moved to approved, Leslie seconded. Minutes approved
- 2. Meeting schedule 1st Thursday of every other month
 - a. The next meeting will be February 1, 2024.
- 3. Roundtable updates
 - a. We are still seeing difficulties with finding people for representation in guardianship
 - i. Especially outside of the Wasatch Front
 - ii. As context, for name/sex changes for minors, there is a roster of lawyers who have agreed to be on a roster to be PGALs in these cases
 - b. The commissioners for the third district family law pro se calendars have had difficulties recruiting volunteers to help
- 4. Navigators (Community Justice Advocate Program)

- a. The Utah Bar Foundation has funded 3 grant applications to help with this
 - I4J to create the Housing Stability Legal Advocate curriculum and then deploy it to social workers and other professionals to provide limited scope help to folks needing help with renter issues
 - ii. Hayley Cousins, from TLC, is starting her own nonprofit Community Justice Innovations to deploy curricula and do administrative work to support community advocates
 - iii. Utah State University will create a debt curriculum and train and support advocates to help with these issues
 - iv. Challenges:
 - 1. Bar Foundation won't cut a check until the application is submitted and the sandbox is not taking applications right now
 - 2. An advocate has to work with the different education providers, the three entities must operate independently. This is suboptimal
- 5. Community voice in the courts
 - a. Alison moved to support the proposal to add more community voice to court administration before the management committee and Dawn seconded. The committee approved the motion
- 6. MyPaperwork
 - a. The group received a sneak preview of the new MyPaperwork program
