## Rule 15-701. Definitions.

- 1 As used in this article:
- 2 (a) "ABA" means the American Bar Association.
- 3 (b) "Accredited School" means a school officially recognized as meeting the standards and
- 4 requirements of a regional or national accrediting organization that is approved by the U.S.
- 5 Department of Education.
- 6 (c) "Applicant" means each person requesting licensure as a Licensed Paralegal Practitioner.
- 7 (d) "Approved Law School" means a law school which is fully or provisionally approved by
- 8 the ABA pursuant to its Standards and Rules of Procedure for Approval of Law Schools. To
- 9 qualify as approved, the law school must have been fully or provisionally approved at the time of
- the Applicant's graduation, or at the time of the Applicant's enrollment, provided that the
- 11 Applicant graduated within a typical and reasonable period of time.
- 12 (e) "Associate Degree" means an undergraduate academic degree conferred by a college
- 13 <u>upon completion of the curriculum required for an associate degree.</u>
- 14 (f) "Bachelor's Degree" means an academic degree conferred by a college or university
- upon completion of the undergraduate curriculum.
- 16 (g) "Bar" means the Utah State Bar, including its employees, committees and the Board.
- 17 (h) "Board" means the Board of Bar Commissioners.
- 18 (i) "Complete Application" means an application that includes all fees and necessary
- 19 application forms, along with any required supporting documentation, character references, a
- 20 criminal background check, a photo, an official certificate of graduation and if applicable, a test
- 21 accommodation request with supporting medical documentation.
- 22 (j) "Confidential Information" is defined in Rule 15-720(a).
- 23 (k) "Disbarred Lawyer" means an individual who was once a licensed lawyer and is no
- longer permitted to practice law.
- 25 (1) "Executive Director" means the executive director of the Utah State Bar or her or his
- 26 <u>designee</u>.
- 27 (m) "First Professional Degree" means a degree that prepares the holder for admission to the
- 28 practice of law (e.g. juris doctorate) by emphasizing competency skills along with theory and
- analysis. An advanced, focused, or honorary degree in law is not recognized as a First
- 30 Professional Degree (e.g. master of laws or doctor of laws).

31	(n) "Full-time" means providing legal services as a paralegal for no fewer than 80 hours per
32	month.
33	(o) "General Counsel" means the General Counsel of the Utah State Bar or her or his
34	designee.
35	(p) "Licensed Paralegal Practitioner" means a person licensed by the Utah Supreme Court to
36	provide limited legal representation in the areas of (1) temporary separation, divorce, parentage,
37	cohabitant abuse, civil stalking, and custody and support; (2) forcible entry and detainer and
38	unlawful detainer; or (3) debt collection matters in which the dollar amount in issue does not
39	exceed the statutory limit for small claims cases.
40	(q) "LPP" means Licensed Paralegal Practitioner.
41	(r) "LPP Administrator" means the Bar employee in charge of LPP licensure or his or her
42	designee.
43	(s) "LPP Admissions Committee" means those Utah State Bar members or others appointed
44	by the Board or president of the Bar who are charged with recommending standards and
45	procedures for licensure of LPPs, with implementation of this article, reviewing requests for test
46	accommodations, and assessing the qualifications of applicants
47	(t) "NALA" means the National Association of Legal Assistants.
48	(u) "NALS" means The Association for Legal Professionals.
49	(v) "OPC" means the Bar's Office of Professional Conduct.
50	(w) "Paralegal" means a person qualified through education, training, or work experience,
51	who is employed or retained by a lawyer, law office, governmental agency, or the entity in the
52	capacity or function which involves the performance, under the ultimate direction and
53	supervision of an attorney, of specifically delegated substantive legal work, which work, for the
54	most part, requires a sufficient knowledge of legal concepts that absent such assistance, the
55	attorney would perform.
56	(x) "Paralegal Certificate" means verification that an individual has successfully completed
57	an accredited paralegal education program.
58	(y) "Paralegal Studies and Paralegal Studies Degree" mean course work that prepares a
59	holder to work as a paralegal.
60	(z) "Privileged Information" in this article includes: information subject to the attorney-client
61	privilege, attorney work product, test materials and applications of examinees; correspondence

62	and written decisions of the Board and LPP Admissions Committee, and the identity of
63	individuals participating in the drafting, reviewing, grading and scoring of the LPP Licensure
64	Examination.
65	(aa) "Reapplication for Licensure" means that for two years after the filing of an original
66	application, an Applicant may reapply by completing a Reapplication for Licensure form
67	updating any information that has changed since the prior application was filed and submitting a
68	new criminal background check.
69	(bb) "Substantive Law-Related Experience" means the provision of legal services as a
70	Paralegal, paralegal student or law student including, but not limited to, drafting pleadings, legal
71	documents or correspondence, completing forms, preparing reports or charts, legal research, and
72	interviewing clients or witnesses. Substantive Law-Related Experience does not include routine
73	clerical or administrative duties. Substantive Law-Related Experience for licensure in landlord-
74	tenant and debt collection includes, but is not limited to, the provision of legal services as a
75	Paralegal supervised by a licensed attorney, paralegal student or law student in the areas of
76	bankruptcy, real estate, mortgage and/or banking law.
77	(cc) "Supreme Court" means the Utah Supreme Court.
78	(dd) "Unapproved Law School" means a law school that is not fully or provisionally
79	approved by the ABA.
80	(ee) "Updated Application" means that an Applicant is required to amend and update her or
81	his application on an ongoing basis and correct any information that has changed since the
82	application was filed.
