The term of office of all elected Council members shall begin with the Council meeting immediately following the annual judicial conference. <u>No person shall serve on the Judicial</u> <u>Council for more than two consecutive three-year terms plus the remainder of any unexpired</u>

27 28 29 30	(2) <u>Election.</u> Election of judicial members of the Council shall take place during the annual judicial conference at the business meeting of each respective court. Election of the representative of the Utah State Bar shall take place at a regularly scheduled meeting of the Board of Commissioners.

33 34	(3)(A) Judges. If a vacancy exists for a judicial member of the Council who represents a
