01 General

➤ <u>01-03.00 Safeguarding of Assets</u>. Updated the Dual Key Log and the Key Assignment Log examples.

02 Receipting

➤ <u>02-12.00 Payments for Other Courts</u>. This section now allows the juvenile court sites to take over the counter cash/check payments intended for another location within the same district.

03 Daily Balancing

➤ <u>03-08.00 Ordering Banking Supplies.</u> Added a new link to the new AOC Finance Docs Forms site to make ordering banking supplies easier and be able to see the status of the order.

07 Purchasing

- ➤ <u>07-03.02 Employee Recognition and Training Event Meals</u>. This section was updated to only include training meal events. The Cash Awards, Cash Equivalent Awards, and Non-cash Awards sections were moved to section 19.
- ➤ <u>07-03.03 Retirement.</u> A change has been made to increase the limit from \$5.00 to \$10.00 a person and increased the amount for refreshments from \$150.00 to \$300.00.
- ➤ <u>07-04.0 Store Account/Cards.</u> This section was updated to include loyalty cards which can be in the name of the employee or the courts.

10 Jury and Witness

➤ 10-02.00 Witness Payments. Paragraphs 10 and 11 were combined to include the requirements for the county attorney and the Attorney General's Office into one paragraph instead of two.

11 Special Funds

- ➤ <u>11-07.00 Grants.</u> This section was re-written to include the new grant policies and procedures.
- ➤ 11-13.00 Targeted Response and Problem Solving Courts Incentive Program. This section was updated to allow adults participating in Family Drug Courts to receive incentives purchased by the court.

12 Travel

- ➤ <u>12-01.00 Per Diem Rates.</u> Clarification on out-of-state lodging.
- ➤ <u>12-03.00 Lodging Reimbursement</u>. Travelers must receive the negotiated rate for the hotel to be considered a conference hotel.
- ➤ <u>12-05.01 Business Use of State Vehicles.</u> Wording was added to clarify when a portion of a trip runs through another state.

13 Budget Management

➤ <u>13-01.00 Budget Management.</u> A paragraph was added to address the costs of employees who live and work outside the State of Utah.
