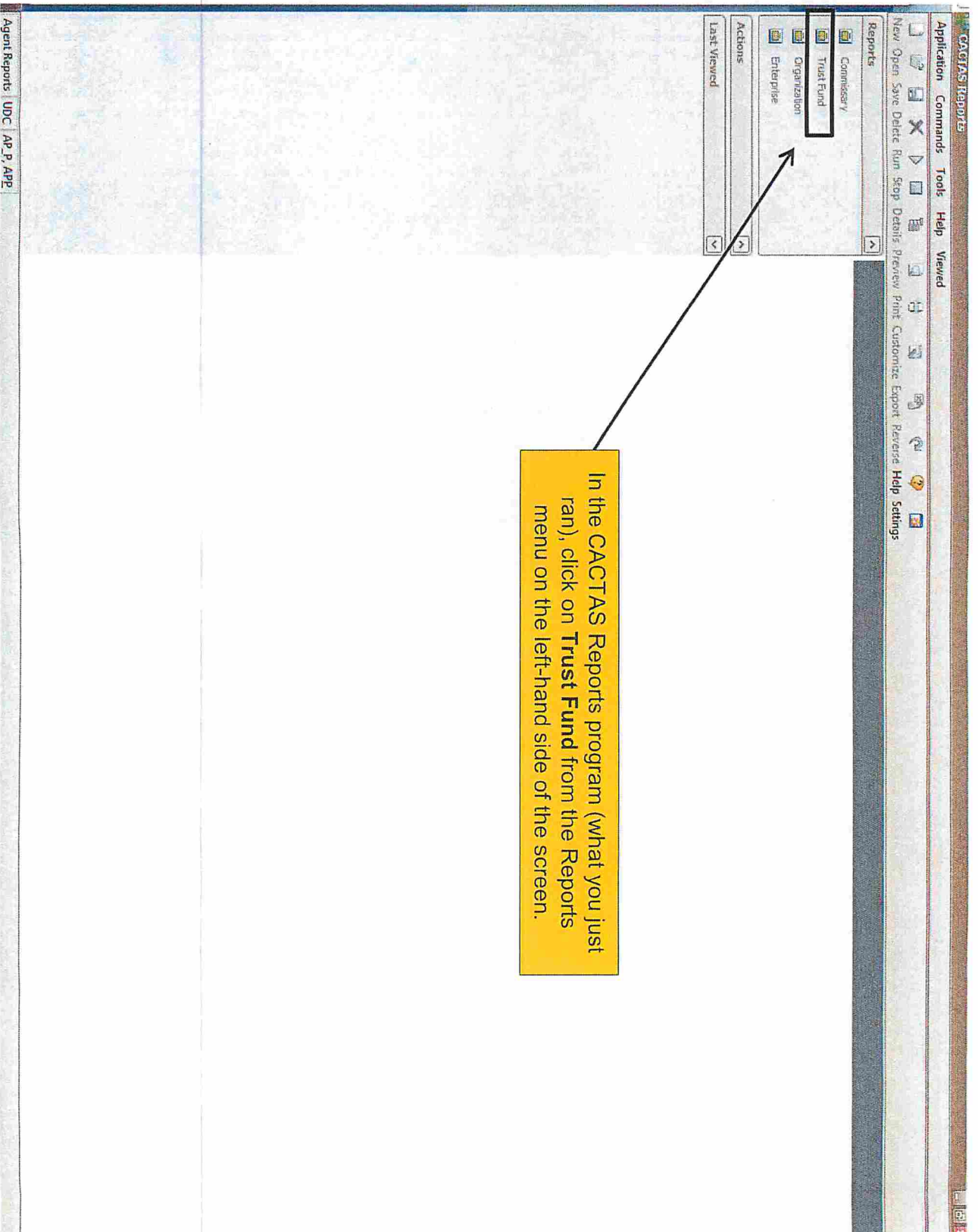

You can sort by any column by single-clicking on any of the column headers. You can also do a filter to see just Active or InActive victims, or any type of filter for each column.

I added Dormant (notice the last column on the right). If a victim is marked Dormant then this means that interest is still accruing but no payments are being mailed to them.

This report shows that the Total Balance still owed on the Fines for this Case # is \$1.06.
