The above-entitled matter was submitted for judgment pursuant to Utah Code Annotated §30-3-4, and Rule 4-913, Code of Judicial Administration, upon the sworn affidavit of the Petitioner, PATTANAN JEERAPATKUL. The Respondent has not filed an answer the Summon and Petition within 21 days. Therefore, the Petitioner is entitled to default judgement. The Court, having before it the testimony of the Petitioner in the form of a sworn affidavit setting forth and establishing jurisdiction and the grounds for divorce, and having before it the other pleadings and papers, and being fully advised in the premises, and having heretofore made and entered Findings of Fact and Conclusions of Law, now, upon motion of Petitioner by and through her attorney,

**HEREBY ORDERS, ADJUDGES, AND DECREES THAT**

**DISSOLUTION OF MARRIAGE**

1. The bonds of matrimony between the parties are dissolved, upon the ground of irreconcilable differences, said act of dissolution to be final upon entry, to the following terms to their divorce.

**PARTIES AND JURISDICTION**

1. The Respondent is a resident of Utah County, State of Utah, and has been a resident thereof for at least three months immediately prior to the commencement of this action in accordance with U.C.A. 30-3-1(2). 2. The Respondent is a resident of Utah County, State of Utah.3. The parties are married, their marriage having been solemnized on October 21, 2025, Ogden City, Weber County, State of Utah.4. The parties have made their marital home together in Utah County, Utah.

5. This Court has jurisdiction over the subject matter of this action pursuant to §§ 78-3-4 and 30-3-1, U.C.A.

6. The parties do not have any minor children. None are expected from this relationship.

#### **GROUND**

7. Certain differences and problems have arisen between the parties which the parties have been unable to overcome or resolve, making the parties unable to continue the marriage.

8. The parties have made the decision to divorce.

#### **ALIMONY**

9. There shall be no alimony paid in this matter by either party.

#### **REAL PROPERTY**

10. The parties have no real property together.

#### **PERSONAL PROPERTY**

11. The parties have already made equitable division of the personal property.

12. Any pensions, retirement plans, retirement accounts, IRA's and other such property interests owned by either party should be awarded to each of them respectively free from any claim by the other.

#### **DIVISION OF DEBTS**

13. The parties shall be responsible for any debt in their own names incurred during the marriage including credit cards, and liens on vehicles. The parties are responsible to pay their own medical bills.

**NAME CHANGE**

14. The petitioner shall keep her current name of PATTANAN JEERAPATKUL .

**ATTORNEY'S FEES**

15. Each party should bear his or her own costs and attorney's fees as long as this matter is uncontested.
