A review hearing was held on June 23, 2025, before the Honorable Commissioner Ito with respect to Heather Wiley (FKA Hulse)'s ("Heather") *Motion to Enforce Order and for Sanctions*. On October 15, 2025, a second review hearing was held before the Honorable Commissioner Ito with respect to Heather Wiley (FKA Hulse)'s *Motion to Enforce Order and for Sanctions*. On February 12, 2026, a third review hearing was held before the Honorable Commissioner Ito. At the October 15, 2025 review hearing, the Court awarded Heather Wiley her attorney's fees. At the February 12, 2026 review hearing, the Court affirmed the award of attorney's fees. Heather submitted a *Declaration of Attorney's Fees*. ***See Court File, 10/29/2025***. The Court, having reviewed the file, and for good cause appearing, hereby ORDERS:

1. Benjamin Hulse shall pay Heather Wiley her attorney's fees in the amount of \$7,036.
2. Benjamin Hulse shall pay Heather Wiley \$500 a month plus standard post judgment interest until the attorney's fees are paid in full.
