In this action the Defendants Rigos Transport, LLC and Rigoberto Gomez having been regularly served with a Summons and Complaint on January 23, 2026 and March 11, 2026, and

having failed to file any motion, demurrer, or answer within the time allowed by law, and the time for which has expired, and the default of the Defendants having been duly entered according to law by the Clerk of the Court, the Court, upon application of the Plaintiff, does hereby enter judgment for the Plaintiff, Central Bank, and against the Defendants Rigos Transport, LLC and Rigoberto Gomez in pursuance of the prayer for relief of the Plaintiff's Complaint.

WHEREFORE by virtue of law, by reason of the premises aforesaid, it is ORDERED, ADJUDGED, and DECREED that the Plaintiff recover from the Defendants Rigos Transport, LLC and Rigoberto Gomez the following, jointly and severally:

1. Judgment is granted in favor of Plaintiff and against the Defendants for breach of the June 25, 2024 Promissory Note in the principal amount of \$80,441.23, plus interest at the contractual rate of 21% per annum.
2. Judgment is granted in favor of Plaintiff and against the Defendants for breach of the July 25, 2024 Promissory Note in the principal amount of \$34,792.91, plus interest at the contractual rate of 21% per annum.
3. Plaintiff's reasonable attorney fees in the amount of \$2,925.00 and court costs incurred in bringing this action in the amount of \$510.00, as proven by separate declaration of counsel.
4. **IT IS FURTHER ORDERED THAT THIS JUDGMENT SHALL BE AUGMENTED IN THE AMOUNT OF ADDITIONAL COSTS AND ATTORNEY FEES EXPENDED IN COLLECTING SAID JUDGMENT BY EXECUTION OR OTHERWISE AS SHALL BE ESTABLISHED BY AFFIDAVIT.**
