**IT IS HEREBY ORDERED, ADJUDGED, AND DECREED:**

Provisions Relating to Termination of Marriage

1. Loni and Steve were married on December 16, 1989, in West Jordan, Utah.

2. The parties are awarded a divorce<sup>2</sup> on the grounds of irreconcilable differences and the marriage between the parties is hereby terminated.

Provisions Relating to Minor Children

3. The parties do not have minor children together and none are expected.

Provisions Relating to Alimony

4. Alimony shall be awarded consistent with the *Stipulated Settlement Agreement*, which has been signed by the parties, and as ordered in the *Findings of Fact and Conclusions of Law*.

Provisions Relating to Real Property

5. All real property owned by the parties is hereby ordered to be resolved and paid in accordance with the *Stipulated Settlement Agreement* and as ordered in the Court's *Findings of Fact and Conclusions of Law*.

Provisions Relating to Personal Property

6. All personal property owned by the parties is hereby ordered to be resolved and paid in accordance with the *Stipulated Settlement Agreement* and as ordered in the Court's *Findings of Fact and Conclusions of Law*.

Other Divisions

7. All other divisions and issues related to this divorce proceeding not mentioned above are hereby ordered to be resolved and paid in accordance with the *Stipulated*

*Settlement Agreement* and as ordered in the Court's *Findings of Fact and Conclusions of Law*.

Miscellaneous Provisions

8. Each party is ordered to execute and deliver to the other such documents as are required to implement the provisions of the Decree of Divorce entered by the Court.
