This matter came before the court on April 21, 2026 regarding Plaintiff's Motion for Order to Show Cause. Plaintiff Meade Recovery Services, LLC was in attendance and represented by counsel, Jonathan E. Jenkins. Garnishee Defendant, Home Away From Home, Care Group, LLC was served at served at 186 South 140 East, American Fork, UT 84003, but has failed to appear. The Court therefore finds:

1. Garnishee Defendant was properly served with a Writ of Garnishment on December 19, 2025.
2. Garnishee Defendant did not comply or respond to the Writ issued by the Court.
3. On March 19, 2026, Garnishee Defendant was served with an Order to Show Cause why Home Away From Home, Care Group, LLC should not be held in contempt for failing to comply with said Writ.
4. Home Away From Home, Care Group, LLC has failed to respond to the orders of this court or demonstrate that it has taken the required steps to secure the judgment owed by Defendant David Madrid.

Based upon the pleadings and information before the court, and good cause therefore appearing.

IT IS HEREBY ORDERED:

1. Garnishee Defendant, Home Away From Home, Care Group, LLC failed to answer the Interrogatories to Garnishee relating to money due and owing to Meade Recovery Services, LLC, and failed to attend the Order to Show Cause hearing.
2. Plaintiff is awarded attorneys fee in the amount of \$350.00 for being required to bring this matter before the court.
3. The total judgment entered against Home Away From Home, Care Group, LLC in favor of Meade Recovery Services, LLC is **\$1,137.99**, which is the prior judgment amount of \$1,811.04 entered against David Madrid plus these new costs: additional attorneys fee of

\$350.00, accrued post judgment interest at the state approved rate, and additional costs incurred in collection of this judgment

Therefore, the amount of the judgment is calculated as follows:
