The court decrees:

Divorce

1. Berenice Gurrola Bojorquez is granted a divorce based on the Declaration of Jurisdiction and Grounds signed by Berenice Gurrola Bojorquez. The divorce will become final upon entry of the divorce decree.

Children (Utah Code 81-6-101(7))

2. **Berenice Gurrola Bojorquez** and **Walter Anibal Garcia Herrera** do not have any children together.

Additional provisions

8. The parties will adhere to the following additional provisions:

Additional Provision: I, Berenice Gurrola Bojorquez, am coowner of a vehicle with mother. The vehicle is a Toyota Corolla 2021 which was purchased prior to the marriage agreement. The main owner is Maria Jesus Bojorquez Rodriguez (my mother). This car is not part of the divorce assets as this was purchase prior to the marriage and it is used to transport my mother to medical appointments, work, etc.

Duty to sign documents

9. The parties will sign all documents necessary to comply with the divorce decree within 60 days from entry of the decree. If a party fails to sign a document within 60 days,
