**Divorce**

### Duty to sign documents

8. The parties will sign all documents necessary to comply with the divorce decree within 60 days from entry of the decree. If a party fails to sign a document within 60 days, the other party may ask the court to appoint someone to sign the document. (Utah Rule of Civil Procedure 70)

### Name after divorce


9. **iesha janay hill** changed **her** name when the parties married. **iesha janay hill's** name will be **iesha janay feria** after the divorce.
