**ORDER GRANTING PLAINTIFF’S  
MOTION FOR SUMMARY JUDGMENT**

This matter is before the Court on Plaintiff’s Motion for Summary Judgment, filed March 12, 2026 (the “Motion”). The Court, having fully considered Plaintiff’s briefing, notes that Defendant failed to file a responsive pleading. Accordingly, the supported facts asserted by Plaintiff in the Motion are deemed admitted. The Court further finds that there is no genuine issue of material fact and that Plaintiff is entitled to judgment as a matter of law.

**IT IS HEREBY ORDERED, ADJUDGED AND DECREED** that Plaintiff’s Motion for Summary Judgment is **GRANTED**.

Accordingly, the Court declares as follows:

1. Judgment is entered in favor of Plaintiff ERC Specialists, LLC and against Defendant Garrett J. Gentry General Engineering Incorporated in the amount of **\$217,711.23**, calculated as follows:

2. Post-judgment interest shall accrue pursuant to Utah Code Ann. § 15-1-4 until paid in full.

**IT IS FURTHER ORDERED** that this judgment may be augmented in the amount of reasonable attorneys' fees and costs incurred in collecting or enforcing the judgment by execution or otherwise which shall be established by affidavit and approved by the Court.
