DEFAULT JUDGMENT

In this action, Defendant Eric McCabe ("Mr. McCabe"), having been regularly and personally served with process and having failed to timely appear and answer the complaint (the "Complaint") of Plaintiff Inside Insurance, LLC ("Inside"), the time allowed by law for answering having expired, and the default of Mr. McCabe having been duly entered according to law, now, upon application of Inside to this Court, Judgment is hereby entered against Mr. McCabe as follows:

WHEREFORE, by virtue of the law, and for the reasons stated above, it is hereby ordered, adjudged, and decreed that Inside is hereby awarded Judgment against Mr. McCabe as follows and as requested in the Complaint:

JUDGMENT

Inside is hereby awarded a Judgment against Mr. McCabe as follows:

1. For the principal amount of \$831,899.37 (the “Principal Judgment Amount”), as requested in the Complaint;
2. For pre-judgment interest on the amount of \$277,299.79, as requested in the Complaint, at the federal postjudgment interest rate in effect for each year in which embezzlement occurred plus 2%, totaling \$80,057.90 as of April 29, 2026, and continuing to accrue at a per diem rate of \$51.47 per day until the date upon which the Court enters Judgment;
3. For Inside’s costs, as requested in the Complaint, through February 18, 2026, in the amount of \$1,156.55, jointly and severally with Ariane McCabe;
4. For Inside’s attorney fees, as requested in the Complaint, pursuant to Utah Code Ann. § 76-6-408(8), in the amount of \$13,532.50; and
5. For postjudgment interest on the Principal Judgment Amount pursuant to Utah Code Ann. § 15-1-4.

Inside may augment this judgment in the amount of additional attorney fees and costs incurred after February 18, 2026.
