hereby submits this Request to Register a Foreign Child Custody Order.

1. Respondent requests to register the attached Child Custody Order. The district court has jurisdiction pursuant to Utah Code 78B-13-305, and 78B-14-602.
2. The parties are the biological and recognized parents of a minor child, K.B., born on September 11, 2009. The order governs current custody and parent time of K.B. between the parties.

3. Respondent's address is 988 Via Stellato St., Henderson, NV 89011.
4. Petitioner's address is 4622 Wellfleet Drive, Huntington Beach, CA 92649.
5. The minor child is currently residing with her aunt Melinda Palmer, who resides at 1395 W 1825 N, Provo, UT 84604. The minor child has been residing there for more than six (6) months.
6. Thus, the minor child has been residing in Utah County for more than six (6) months.
6. The Custody Order attached is the controlling order regarding the custody and parent time of K.B.. Such order is described below.
7. Respondent asserts the Order is the controlling order.
  - (a) The name of the Order is the "Formal Order After Hearing." It includes order regarding physical and legal custody of the subject minor child, K.B.

The above captioned matter came on for a hearing on August 20, 2025, at 10:30 AM in department C17 of the Central Courthouse, before Honorable Michele Bell. Petitioner, CRAIG M. BLEDSOE, in pro per, Respondent, KEELEEE J. BLEDSOE, with attorney of record Burke Huber, Esq., and Minor's Counsel, Tracy Willis, Esq. present remotely via Zoom. After hearing from parties and Minor's Counsel, the court makes the following findings and orders:

1. All prior orders shall remain in full force and effect, other than as modified herein.
2. The Courts tentative is to order the minor child to return to Las Vegas, Nevada with Respondent.
3. Minor's Counsel requests a chamber's interview for the minor child, Keerslee.
4. The Court trails this matter to allow the Court to hold an in-chamber's interview with the minor child and minor's counsel present at 3:00pm via Zoom. Thereafter, the court will address the parties at 3:20pm.

- 1 5. The Court, the minor child, Keerslee, and the minor's counsel held an in-chamber's  
2 conference with the court reporter present via Zoom.  
3  
4 6. The matter is back on record at 3:36 pm. Petitioner is present in open court,  
5 Respondent, Respondent's Counsel, and Minor's Counsel are present in open court  
6 via zoom.  
7  
8 7. The Court finds the minor child is credible and not manipulated or coached by either  
9 party.  
10  
11 8. The Court indicated the Petitioner has been making decisions that are child-focused  
12 although he acknowledges he did take the minor child out of the state without a  
13 court order.  
14  
15 9. The Court finds the Petitioner is credible.

16 **10. CUSTODY:**

- 17 a. Sole legal and sole physical custody of the minor child, Keerslee Bledsoe  
18 (DOB: 09/11/2009) is awarded to the Petitioner. Additionally the Court  
19 authorizes the relocation of the minor child to the state of Utah.

20 **11. CHILD SUPPORT:**

- 21 a. Child support set for the minor child, Keerslee Bledsoe, to be set at zero  
22 retroactive from December 3, 2025.  
23  
24 b. The Court continues this matter only to address child support on October 28,  
25 2025, at 8:30 am in department L54 of the Lamoreaux Justice Center,  
26 located at 341 The City Drive S, Orange, CA 92868.  
27  
28 c. Both parties are to file updated Income and Expense Declarations 10 days  
prior to the next hearing date abiding by Orange County Local Rule 702.

1           **12. MINOR'S COUNSEL FEES:**

- 2           a. The Court reallocates the minor's counsel fees (100 percent) to the
- 3           Respondent; however, the Respondent is invited to file a Fee Waiver to
- 4           allow the court to reallocate the fees to the County of Orange. The court will
- 5           not reimburse the parties for the retainers paid to Ms. Tracy Willis.

7           13. The Court order's Minor's Counsel relieved upon filing of the Findings and Order

8           After Hearing.

- 11           a. This Court has jurisdiction to make child custody orders in this case under
