The court has entered its findings of fact and conclusions of law on the above titled matter and found that a Decree of Divorce is warranted in this matter. That parties have completed all requirements for the entry of a decree, or such requirements have been waived.

The court, being fully advised, hereby ORDERS AND DECREES AS FOLLOWS:

PARTIES, JURISDICTION & GROUNDS

1. Petitioner and Respondent were married on March 11th, 2023.
2. The parties were residents of Utah County, Utah on the date this case was filed.
They were residents for at least 90 days immediately before filing this case.

3. Grounds for Divorce: the parties have experienced irreconcilable differences that have prevented the parties from pursuing a viable marriage relationship. Therefore, the Petitioner is awarded a *Decree of Divorce* from the Respondent.

4. The parties separated on January 22nd, 2026.

PROVISIONS RELATING TO MINOR CHILDREN

5. There are no minor children at issue in this marriage.

PROVISIONS RELATING TO PERSONAL PROPERTY

6. All personal property not addressed in the divorce should be divided as the parties have already divided it.

7. Respondent will receive \$3,000 fourteen (14) days after the signing of the Decree in full settlement of all financial issues other than what is stated in paragraph 15.

8. Respondent will remain as the beneficiary of, and bear all responsibility for, the life insurance policy for the Petitioner, and she agrees to the following terms: The parties agree that the life insurance will cover 100% of the costs associated with the death and burial of Tanner Iverson incurred by the estate, which is \$51,574. Respondent will not be liable for costs that exceed this amount. Respondent will be entitled to any remaining amounts. Respondent agrees that the life insurance may reimburse the Estate of Petitioner directly for costs already incurred, but if they cannot, she will pay the estate directly within 10 days of receipt of funds.

9. The parties White gold/ diamond engagement ring and wedding band. Current value is \$8,000, based on an estimated appreciation of the original purchase price. Respondent should receive this item free and clear.

10. The parties Dog, Winnie, will be the sole property of the Respondent and the parties will work together to get the dog to Respondent within 14 days of the signing of

this document.
