Additional Provision: Both parties shall not harass, threaten, intimidate, stalk, or disturb the peace between Petitioner and Respondent.

b.

Additional Provision: All communication between Petitioner and Respondent shall be limited to written communication only (email or text), and only for issues reasonably necessary to address legal, financial, or procedural matters related to this case.

c.

Additional Provision: Petitioner and Respondent shall have no in-person contact with each other while this action is pending, except as may be expressly authorized by further order of the Court.

d.

Additional Provision: Respondent shall have no contact, direct or indirect, with Petitioner's children, Jacob Johnson and Sierra Johnson, including but not limited to in-person contact, telephone calls, text messages, emails, social media, or contact through third parties, while this action is pending.

e.

Additional Provision: Respondent and petitioner shall not interfere with either parties housing or residency including attempts to force cohabitation, remove Petitioner Respondent from a residence or otherwise disrupt each others housing stability. Neither party shall seek the location of either's residence except as required for lawful service of court proceedings

f.

Additional Provision: petitioner and respondent shall conduct themselves in a manner that avoids conflict, escalation, or disturbance, and shall take all reasonable steps to maintain peace and stability, particularly where minor

children are concerned.

g.

Additional Provision: Neither party shall speak negatively about the other party to or in the presence of any of the children, including Jacob Johnson, Sierra Johnson, Ben Heinrichs, and Mckenzie Heinrichs, and neither party shall involve any of the children in adult disputes, legal matters, or conflicts between the parties.

h.

Additional Provision: Petitioner and respondent shall not use third parties to contact, harass, pressure, or convey messages to either party or to either parties children while this action is pending.

i.

Additional Provision: Both parties shall be restrained from transferring, concealing, damaging, encumbering, or disposing of marital or personal property, except in the ordinary course of daily living, without written agreement of the parties or further order of the Court.

j.

Additional Provision: Both parties shall maintain the financial status quo and shall not incur unreasonable debt, close accounts, or interfere with access to funds reasonably necessary for ordinary living expenses while this action is pending.

k.

Additional Provision: Each party shall have temporary exclusive use of his or her own personal property necessary for daily living and employment, including personal effects, identification documents, work-related items, and prescribed medications, pending further order of the Court.

l.

Additional Provision: Petitioner nor his family shall have no contact, direct or indirect, with respondent's children, Makenzie Heinrichs and Ben Heinrichs, including but not limited to in-person contact, telephone calls, text messages, emails, social media, or contact through 3rd parties, while this action is pending.

Duty to sign documents

13. The parties will sign all documents necessary to comply with the divorce decree within 60 days from entry of the decree. If a party fails to sign a document within 60 days, the other party may ask the court to appoint someone to sign the document. (Utah Rule of Civil Procedure 70)
