THIS MATTER, comes before the Honorable Commissioner Marla Snow on May 5, 2026, for hearing on Petitioner's Motion to Terminate Alimony. Present were Respondent and her attorney, John Larsen appearing remotely, and Petitioner and his attorney, Scott Weight appearing in person. Having considered the evidence and based on the findings stated on the record, the Court HEREBY ORDERS:

1. Petitioner's alimony obligation is terminated as of December 1, 2025.
2. Petitioner has overpaid alimony in the amount of \$4,500 (December 2025-April 2026) and therefore judgment is entered in favor of Petitioner and against Respondent in the amount of \$4,500.
3. Petitioner was awarded his attorney's fees as a judgment against Respondent. Therefore, Petitioner is awarded further judgment against Respondent in the amount of \$2,659.50.
4. The total judgment entered against Respondent and in Petitioner's favor is \$7,159.50.
