DECREE OF DIVORCE

This matter came before the Court on the parties' Request to Submit. Good cause appearing, and having previously entered its Findings of Fact and Conclusions of Law, the Court enters the following DECREE OF DIVORCE:

DECREE OF DIVORCE

1. The parties are granted a Decree of Divorce based on grounds of irreconcilable differences.

Real Property

2. The parties will list and sell their marital home. The parties will mutually agree to a realtor and will follow the recommendations of the realtor as to the listing price, accepting offers, and making counter-offers.

a. When the home is sold, the sales costs and home mortgage will be paid in full.

b. After the mortgage and costs of sales are paid in full, the parties will pay the following marital debt:

- i. AFCU VW Tiguan: \$5,920.82
- ii. UCCU Buick Encore: \$4,691.10
- iii. CBE Group (Stacie): \$9,816.93
- iv. CBE Group (Jacob): \$1,299.89
- v. CBE Group (Colin): \$812.73
- vi. CBE Group (Taylor): \$179.56
- vii. Mountain Land Collections (Stacie): \$917.54
- viii. Mountain Land Collections (Jacob): \$251.78
- ix. Check City: \$4,534.90
- x. Security Services Checking: \$1,223.90
- xi. Empower Retirement Loan: \$4,050.63

- xii. Nelnet (Colin): \$16,694.39
- xiii. Nelnet (Stacie/Megan): \$95,856.98
- xiv. Any debt remaining after exhausting the proceeds from the sale of the home will be shared by the parties 50%-50%.
- xv. Any proceeds from the sale of the home left after paying the debts listed will be equally divided between the parties.

3. Until the home is sold, Colin will continue to pay the car insurance, car loans, and cell phone bill and maintain mortgage, utilities, taxes and insurance related to the home.

Debt

4. Marital debts will be paid off as outlined above. Any debt not listed above is the responsibility of the party whose name is on the debt.

Personal Property

- 5. Colin is awarded the Volkswagen Tiguan and all property currently in his possession.
- 6. Stacie is awarded the Buick Encore and all property currently in her possession.
- 7. Stacie agrees to make digital copies of all family pictures for Colin within 18 months of the entry of the Decree of Divorce.

Financial & Retirement Accounts

- 8. Each party is awarded the bank accounts in their name.
- 9. Colin is awarded his pension account from the UK.
- 10. Stacie is awarded the Empower retirement account. Colin should prepare the QDRO for this plan within 90 days after the Decree of Divorce is entered.

Alimony

11. The parties are each capable of providing for themselves, there will be no alimony ordered in this case.

Name Change

12. Stacie may be restored to her maiden name of "Peterson" if she so chooses.

Trust

13. As of the date the Decree of Divorce is entered, any and all agreements, governing documents, or distributive provisions related to the family trust are terminated by mutual consent.

14. This resolves all outstanding issues related to the parties divorce.
