This Court, pursuant to Rule 58A of the Utah Rules of Civil Procedure, hereby enters JUDGMENT in favor of Defendants in this matter as follows:

1. Pursuant to the Court's Order entered September 10, 2025, the Court dismissed Plaintiff's claims against the non-appearing entities Defendants Crown Equipment Leasing, LLC, Crown Equipment Manufacturing, and OKI Systems Limited without prejudice (Dkt. 109);
2. Pursuant to the Court's Order entered January 12, 2026, the Court dismissed Plaintiff's claims against Defendant East Penn Manufacturing with prejudice (Dkt. 176); and
3. Pursuant to the Court's Order entered April 27, 2026, the Court dismissed Plaintiff's claims against Defendant Crown Equipment Corporation dba Crown Lift Trucks with prejudice (Dkt. 197).

Accordingly, the Court hereby enters judgment in favor of Defendants and against Plaintiff Hailey Dietz. Each of Plaintiff Hailey Dietz's claims is hereby DISMISSED.
