The matter before the Court is Plaintiff's uncontested Motion for Summary Judgment.

Having reviewed the unopposed motion and finding good cause as stated therein—

THE COURT HEREBY ORDERS that Plaintiff is awarded judgment in its favor and against the Defendant, Stevie Jill Kindig, in the amount of \$4,298.61 together with post-judgment interest at 18% APR from the date of judgment, plus all costs of collection, including reasonable attorney's fees. The judgment consists of:

Clarinet contract damages (\$777.50 lease payments, \$175.00 late fees, \$1,069.13 Clarinet value)	\$2,021.63
Clute contract damages (\$670.25 lease payments, \$175.00 late fees, \$854.23 Flute value)	\$1,699.48
Attorney's fees pursuant to the contract and Rule 73(f)	\$350.00
Complaint filing fee	\$200.00
Service of process fee charged by Sevier County Sheriff	\$27.50
Total Judgment	\$4,298.61

The Clerk of the Court is directed to enter said judgment.

THE COURT FURTHER FINDS AND DECLARES as follows:

Plaintiff has a right to possess that certain Yamaha Clarinet Serial No. N77784 (“Clarinet”) or to collect the value of the Clarinet plus sales tax, totaling \$1,069.13, as awarded above. Plaintiff is entitled to a Writ of Replevin for the Clarinet. If the Clarinet is returned in normal used condition, fair wear and tear excepted, Plaintiff will credit the Defendant \$1,069.13 towards the judgment balance at that time, less \$31.10 per month, starting June 1, 2026.

Plaintiff has a right to possess that certain Cannonball Flute Serial No. 161050 (“Flute”) or to collect the value of the Flute plus sales tax, totaling \$854.23, as awarded above. Plaintiff is entitled to a Writ of Replevin for the Flute. If the Flute is returned in normal used condition, fair wear and tear excepted, Plaintiff will credit the Defendant \$854.23 towards the judgment balance at that time, less \$26.81 per month, starting June 1, 2026.
