DEFAULT JUDGMENT

Based upon the default of Defendant, Nancy Bridgette Delatorre, the pleadings on file,
proper notice to Defendant, and good cause appearing, it is hereby

ORDERED, ADJUDGED AND DECREED that a Default Judgment be issued as
follows:

I. Judgment in the amount of **\$5,652.87**, which is calculated pursuant to the
following:

A. \$3,116.07 for assessments, late fees, interest and other charges owed to
Plaintiff as of the date of the Complaint;

- B. \$611.00 in additional monthly assessments for May 2025 through May 2026, which have accrued after the date of the Complaint;
- C. \$60.00 for late fees for April 2025 through May 2026;
- D. \$648.30 for interest accrued on Defendant's unpaid account with the Plaintiff from April 30, 2025 through May 2026, and the parties' contractual rate of eighteen percent (18%) per annum;
- E. \$892.50 in pre-judgment attorney's fees for Plaintiff's collections efforts against Defendant related to the prosecution of this action;
- F. \$325.00 in pre-judgment costs and expenses incurred by Plaintiff for its collection efforts against Defendant;

II. Post-judgment interest accruing at the parties' contractual rate of eighteen percent (18%) per annum until the judgment is paid in full, pursuant to Utah Code § 15-1-4 and 57-8a-306;

III. Pursuant to Utah Code § 57-8a-306(1), post-judgment attorneys' fees, costs, and expenses incurred by Plaintiff in collecting on this judgment until it is paid in full, which may be established by affidavit.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that:

- I. This judgment may be augmented in the amount of after-accruing assessments, fines and reasonable costs and attorney fees expended in collection of said judgment by execution or otherwise as shall be established by affidavit.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that:

I. Plaintiff's lien, which secures the payment obligation due by the Defendant to Plaintiff, is a good and sufficient lien upon the property located at 1681 E. Shadow Drive, Eagle Mountain, Utah 84005 (the "Property"), which Property is more particularly described as: 3

Lot 207, Plat 2, Sweetwater Subdivision, according to the official plat thereof as recorded in the office of the Utah County Recorder, State of Utah.

Subject to easements, restrictions, and rights of way appearing of record or enforceable in law and equity and year 2021 taxes and thereafter.

Together with all improvements and appurtenances thereunto belonging.

Parcel No.: 66:339:0207;

II. That Plaintiff's lien for assessments and other past due amounts is a good and sufficient lien upon the Property securing the payment of the obligations due by Defendant;

III. That Plaintiff's interest in the Property is superior to any and all of Defendant's interest in the Property;

IV. The Property be foreclosed and sold by the Sheriff of Utah County, Utah according to the law and practices of this Court to satisfy the amounts which may be found herein due and owing to Plaintiff;

V. That any amounts charged by the Sheriff to conduct the sale of the Property be added to the amount of the judgment and the lien;

VI. That the foreclosure of the Association's lien in the Property is superior to and not subject to any Homestead Exemption claim pursuant to Utah Code § 57-8a-306;

VII. Plaintiff may become a purchaser at the sale;

VIII. Following the sale, the Sheriff of Utah County be ordered to execute and deliver a Certificate of Sale as required by law, and that upon the expiration of the period of redemption as prescribed by law, the Sheriff be ordered to execute and deliver a deed to the purchaser of the Property and that the purchaser be let into possession of the Property;

IX. That Plaintiff may have judgment and execution against Defendant for any deficiency that may remain after applying the proceeds (if any) from the sale of the Property to the satisfaction of the judgment;

X. That Plaintiff may have a claim against Defendant for any post-judgment amounts which accrue on the Defendant's account with the Association and which amounts are not otherwise included in the balance of the Association's lien against the Property at the time of the sale of the Property, which amounts may be satisfied in full or in part from any excess proceeds from the sale of the Property; and

XI. That in the event there are any excess funds from the Sheriff's sale that such funds be deposited with the Court.
