The above-captioned matter having come before the above-referenced Court, the Court having reviewed the file and finding the necessary pleadings in the file, the Court having entered its Findings of Fact and Conclusions of Law, and being otherwise fully advised states:

**IT IS HEREBY ORDERED, ADJUDGED, AND DECREED:**

Provisions Relating to Termination of Marriage

1. Hilda and Gerry were married in Provo, Utah, on November 14th, 2014.
2. Hilda is awarded a divorce from Gerry on the grounds of irreconcilable differences, and the marriage is hereby terminated.

Provisions Relating to Minor Children

3. The parties have no minor children and none are expected.

Provisions Relating to Taxes

4. The parties will file their own taxes in 2025. The parties will only be responsible for their own tax liability for 2025 and other tax years in which they filed separately.

Provisions Relating to Alimony

5. Neither party is in need of any alimony therefore it should be waived now and forever in the future.

Provisions Relating to Real Property

6. The parties have acquired two locations of real property.
  - a. Gerry is awarded the real property at 187 E. 1780 S. Orem, UT 84058. This party is currently under contract for sale. Gerry should get all the proceeds of the sale and be responsible for any taxes, costs or any other liability on this property.
  - b. Hilda is awarded the real property located at 450 E. 1600 S. Orem, UT 84058 and any equity associated with this property.
7. Hilda had the real property at 1191 W. 1380 N. Orem, UT 84057 prior to the marriage and is awarded this property free and clear of any claim by Gerry.

Provisions Relating to Personal Property

**8.** Each party is awarded their own separate personal property that they acquired before their marriage.

**9.** Each party is awarded the vehicles in their own name. Neither party has any claim to vehicles not currently in their own names.

**10.** All other personal property acquired during the marriage is divided as the parties may agree. If they cannot agree they will sold and the proceeds divided. If the parties disagree with sale of the personal property division and do not want to sell it, they must attend mediation prior to filing a legal action.

#### Provisions Relating to Financial/Bank Accounts

**11.** The parties do not have a joint bank account or financial account.

**12.** All other accounts are awarded to the person who's name is on the account free and clear of any claim by the other party.

#### Provisions Relating to Investment Accounts and Retirement Accounts

**13.** The parties will each keep their own investment and retirement accounts free and clear of any claim by the other party.

#### Provisions Relating to Debts

**14.** The parties do not have any marital debt. However any marital debt is discovered, the debt will be the sole responsibility of the party who incurred the debt no matter the reason.

**15.** Each party is responsible for all the debts in their own names.

#### Provisions Relating to Attorney's Fees and Costs

16. The parties will each pay their own attorney's fees and costs incurred in prosecuting this action.

Miscellaneous Provisions

17. Each party is ordered to execute and deliver to the other such documents as are required to implement the provisions of the Decree of Divorce entered by the Court.
