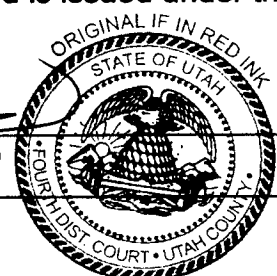

**ORDER FROM MOTION TO ENFORCE  
HEARING 5.18/2026**

Civil No. 254400366

THE PARTIES came before the honorable Judge Eyre, who was filling in for Commissioner Ito, regarding Respondent's motion to enforce and Respondent's counter motion to enforce on May 18, 2026, at approximately 9:00 am. Respondent, Danielle Shaw (Danielle), was present and represented by her counsel of record, Jason Fuller. Petitioner Ryan Warner ("Ryan") was present and represented by counsel of record, Stephen Nemelka. After argument, the Court ordered as follows:

1. Ryan will pay Danielle \$5,500 for half of the money he owes regarding the 11 months of \$1,000 for failing to refinance the home. The Court finds that both parties share some blame and so, Ryan will only be required to pay half.

2. Ryan will refinance the house within 3 weeks from May 18, 2026, or the home will be immediately listed for sale with Respondent's choice of realtor, Marci Bliss.

3. Ryan shall pay to Danielle the auto insurance amount he disputed after the divorce was final for and received via refund to the card he had on file when the policy was established in the amount of \$5,054.44 (the amount he was refunded for payment made during the parties' marriage).

4. Ryan shall pay Danielle for one-half the reimbursement of homeowner's insurance premiums in the amount of \$1,031.18.

5. The Court enters judgment of \$11,585.62 with post judgment interest in favor of Danielle.

6. There will be no further obligation going forward for Ryan to pay additional amounts.

7. Danielle will cooperate with lenders or refinance via counsel or otherwise to assist with the refinance.

8. The Court does not award attorney's fees and does not find contempt for either party.
