The parties proffered a stipulation to resolve the issues raised in Melissa Marie Guilmette's divorce petition.

The court has jurisdiction to enter a final divorce decree.

The court accepts the parties' Stipulation and Declaration of Jurisdiction and Grounds for Divorce and enters its findings of fact:

Residency

1. Melissa Marie Guilmette and Darshan Jani fall under the "exemption" in Utah residency non-required for, divorce (Utah Code 81-2-303(5)(1)(ii)(2024) since they both signed an affidavit requirement when obtaining a marriage license whereby absent parties consent to Utah jurisdiction for future divorce.

2. **Melissa Marie Guilmette** and **Darshan Jani** were married on **October 23, 2023** in **Provo, Utah County, Utah**.

Grounds and divorce

3. **Melissa Marie Guilmette** asks for a divorce from **Darshan Jani** on the grounds of irreconcilable differences. The irreconcilable differences are:

We are separated because of problems in the marriage, and despite best efforts, we cannot get back together to make the marriage work.

4. **Melissa Marie Guilmette** and **Darshan Jani** separated on **July 26, 2025**.

Children (Utah Code 81-6-101(7))

5. **Melissa Marie Guilmette** and **Darshan Jani** do not have any children together.

- We do not have any children together who are minors. A minor is a child under 18 who has not been married or otherwise emancipated.
- We are not expecting a child.
- We do not have incapacitated adult children together who are eligible for child support, or, **Melissa Marie Guilmette** is not asking for child support for any adult child who is eligible for child support.
