The court decrees:

## Divorce

1. Christian Felix Verspohl is granted a divorce based on the Declaration of Jurisdiction and Grounds signed by Christian Felix Verspohl. The divorce will become final upon entry of the divorce decree.

Children (Utah Code 81-6-101(7))

2. **Christian Felix Verspohl** and **Yaqing Hu** do not have any children together.

**Additional Provision: All financial and personal issues have been agreed upon both parties based on a mutual contract signed on 3 31 2026 in Yiwu China. Therefore no property, asset or any other help from the court is needed.**

### Duty to sign documents

9. The parties will sign all documents necessary to comply with the divorce decree within 60 days from entry of the decree. If a party fails to sign a document within 60 days, the other party may ask the court to appoint someone to sign the document. (Utah Rule of Civil Procedure 70)

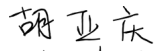
