6. **Keylee Belle McKinney** and **Kyle Louis Wilkinson** have physical custody of our child(ren), and are the only people who have custody, child support, and parent-time rights to our child(ren).

PARENTING PLAN

This Parenting Plan is being filed in good faith.

This parenting plan is agreed to by **Keylee Belle McKinney** and **Kyle Louis Wilkinson**.

Children - custody

(Utah Code Title 81, Chapter 9, Part 3)

7. It is in the children's best interest that **Keylee Belle McKinney** be awarded Sole Legal and Sole Physical custody **Kyle Louis Wilkinson** should have parent-time at reasonable times and places.

Parent-time

8. The parents will follow a custom parent-time schedule:

The parents will follow a custom parent-time schedule.

- a. **Keylee Belle McKinney will have sole physical and legal custody of both children. Kyle Louis Wilkinson will have supervised visitation rights during daytime hours (Kyle Louis Wilkinson is to never have the children alone overnight but is allowed to stay the night at Keylee Belle McKinney's home if both Kyle Louis Wilkinson and Keylee Belle McKinney deem it necessary for a reason (I.e. sickness)). Kyle Louis Wilkinson is not allowed to be alone with the children unless he has written approval to be alone with the children that has a wet signature from Keylee Belle McKinney. Kyle Louis Wilkinson shall have supervised parent-time with the minor children for a minimum of eight (8) hours per week. Keylee Belle McKinney and Kyle Louis Wilkinson acknowledge that due to works schedules, unforeseen circumstances or other life events,**

Kyle Louis Wilkinson will occasionally be unable to exercise the full minimum visitation rights in a given week. However, weeks in which Kyle Louis Wilkinson exercises fewer than eight (8) hours of visitation will not exceed eight (8) weeks within any calendar year.

Parent-time for special occasions

9. The parents will follow the schedule for special occasions below. If there is more than one child and the children's school schedules vary for purpose of a holiday, at the option of the parent exercising the holiday or the parent's half of the holiday, the children may remain together for the holiday period beginning the first evening that all children's schools are let out for the holiday and ending the evening before any child returns to school. Parent-time transfers

10. Pick-up and drop-off ("transfers") of the children for parent-time will be as described below:

The parties will make arrangements for pick up, delivery and return of the children prior to each scheduled parent-time.

Curbside transfers

11. There will not be curbside transfers. The parent/person dropping-off or picking-up a child may accompany the children to the other parent/person when parent-time transfers are made.

Decision-making

12. Each parent will make day-to-day decisions for the children during the time they are caring for the children. Either parent may make emergency decisions affecting the health or safety of the children. A parent who makes an emergency decision must share the decision with the other parent as soon as reasonably possible.

Education plan

13. The school the children will attend is based on **Keylee Belle McKinney's** home residence.
14. Keylee Belle McKinney has authority to check the children out of school. Keylee Belle McKinney has access to the children during school. If the parents cannot agree, education decisions will be made by Keylee Belle McKinney.

Communication with the children

16. The parents agree they will:
- provide age-appropriate help to the children to communicate with the other parent.
 - give the children privacy during their communication with the other parent. The parents will not interfere with or monitor communication between the children and the other parent.
17. Parents and children may communicate with each other whenever the children choose.
- By any method

Records and information sharing

18. Other terms regarding records and information sharing:
- Unless it is an emergency situation, Keylee Belle Mckinney will be the sole person to consult with providers regarding education, child care, and health care.**

Travel by the children

19. During their parent-time, the parent may consent for the children to travel with a sports team, religious group, school group, relatives, friends, by themselves, or with others.
20. If the children will be travelling for more than **5** days, the parent arranging the travel will notify the other parent at least **5** days in advance. That parent will give the other parent the travel schedule, locations and phone numbers at least **5** days in advance. In

case of emergency, the parent will provide as much notice as possible.

21. Other agreements about travel by the children: **Kyle Louis Wilkinson is not permitted to travel with the children without Keylee Belle McKinney, unless he has written permission with a wet signature from Keylee Belle Mckinney.**

Child care

22. A child care provider for our children must be:

Other qualifications: **The child care provider must be approved by Keylee Belle McKinney.**

Relocation of a parent

23. Neither parent may relocate with the minor children more than **20** miles from their current residence without a written agreement signed by the parties or further court order.

24. Other terms about relocating: **Since Keylee Belle Mckinney will have sole legal and physical custody of the children, Kyle Louis Wilkinson is not allowed to relocate with the children.**

25. If either parent lives more than 149 miles away from the other or the parents live in separate countries, costs for the children's travel expenses for parent-time will be shared equally.

26. If a parent has been found in contempt for not being current on all support obligations, and they do not have primary physical care of the child, they will be responsible for the child's related travel expenses.

27. Reimbursement for the child's travel expenses must be made within 30 days of receipt of documents detailing those expenses.

Changing the plan

This plan remains in effect until changed. A change comes from a modification of a court order.

Child support (Utah Code Title 81, Chapter 6, Parts 1 and 2)

31. **Keylee Belle McKinney** believes the guideline amount for child support is unjust, inappropriate, or not in the best interest of our children for the following reasons:

The reason(s) for deviation are \$3,100 is the amount that Keylee Belle McKinney and Kyle Louis Wilkinson have agreed is appropriate for the monthly child support amount..

32. It is in the best interest of the children that be ordered to pay child support to as follows:

- a. **\$3,100.00** per month. This deviates from the Utah Uniform Child Support Guidelines.
- b. Unless the Court orders otherwise, support for each child ends when:
 - a child turns 18 or has graduated from high school during the child's normal and expected year of graduation, whichever occurs later, or
 - a child dies, marries, becomes a member of the United States armed forces, or is emancipated (Utah Code 78A-6-801).

33. Once a child is no longer eligible to receive child support, the support amount for the eligible children should be recalculated using the child support worksheet (Utah Code Title 81, Chapter 6, Parts 1 and 2). The parties may not divide the base child support award by the number of children and subtract that amount from the prior child support amount.

34. The person ordered to receive child support can request mandatory income withholding (Utah Code 62A-11 parts 4 and 5). If support is past due, the State of Utah may take federal or state tax refunds or rebates and apply the amounts to the child support owed.

- a. Withheld income will be sent to the Office of Recovery Services (ORS) until all past-due support is paid. Child support payments will be sent to:
150 East Center Street, Suite 2100 Provo, Utah 84606
unless ORS gives notice that payments should be sent elsewhere.

35. If ORS begins mandatory income withholding, child support is due on the first day of each month and will be past due on the first day of the next month.

36. The issue of past-due child support may be decided by future court or administrative action.

37. **Keylee Belle McKinney** and **Kyle Louis Wilkinson** will each pay half of any ORS fee.

- a. If a fee is withheld from payments to , will reimburse for half the fee.

38. The parties must notify each other within 30 days of any change in their income.

39. The parties will do the following for child related support or expenses:

- a. Kyle Louis Wilkinson should pay Keylee Belle McKinney 50% of all his bonus income for additional child support.
- b. Once the child(ren) turn 18 years old, they will remain on Kyle Louis Wilkinsons

health and dental insurance until they are 26 years old or until they legally marry, whichever comes first. Furthermore, any medical expense that is not covered by the health insurance plan will be split 50/50 by Keylee Belle Mckinney and Kyle Louis Wilkinson.

c. Once the child(ren) turn 18 years old, shall they choose to attend college or some sort of continued education, Keylee Belle Mckinney and Kyle Louis Wilkinson will equally split all expenses such as tuition, books, room and board, etc. Payments from Kyle Louis Wilkinson for these matters should be paid directly to Keylee Belle Mckinney. Keylee Belle Mckinney will manage both children's financial accounts such as college saving funds, checkings, savings, etc.

d. When the child(ren) are at legal driving age, Keylee Belle Mckinney and Kyle Louis Wilkinson will 50/50 split all associated costs such as: Drivers education course fees, permit and license fees, car payment, and drivers/car insurance.

40. The Office of Recovery Services (<https://ors.utah.gov/>) provides services to individuals who are seeking assistance in the collection or enforcement of child support orders.

Child health care (Utah Code 81-6-208)

43. The parties must provide health care coverage for the medical expenses of the dependent children. Health care coverage means coverage under which medical services are provided to a dependent child through: fee for service, a health maintenance organization, a preferred provider organization, any other type of private health insurance, or public health care coverage. Utah Code 81-6-101(14),

44. Kyle Louis Wilkinson must maintain medical, hospital, and dental care insurance for the dependent children if it is available at reasonable cost. If medical insurance is not available at reasonable cost then both parents must ensure the children have health care coverage. This may require applying for public health care coverage, such as CHIP or Medicaid.

a. If, at any time, a dependent child is covered by the medical, hospital, or dental insurance plans of both parents, the coverage will be as follows:

- **Kyle Louis Wilkinson's** insurance will be primary coverage.

- **Keylee Belle McKinney's** insurance will be secondary coverage.
- b. If a parent remarries and that parent's dependent child is not covered by that parent's health, hospital, or dental insurance plan but is covered by a step-parent's plan, the coverage will be as follows:
 - **Kyle Louis Wilkinson's** spouse's insurance will be primary coverage.
 - **Keylee Belle McKinney's** spouse's insurance will be secondary coverage.
- c. Both parties will equally share the out-of-pocket costs of the insurance premiums.
- d. Both parties will equally share all uninsured and unreimbursed medical and dental expenses that are reasonable and necessary. This includes deductibles, co-insurance, and co-payments paid by a party for the dependent children.
- e. The party who pays health care expenses must provide the other party written verification of the cost and payment within 30 days.
- f. If a party does not follow this order and provide written verification, they may not be able to receive credit for health care expenses or recover the other party's share of the expenses.
- g. On or before January 2 of each year, the party ordered to maintain coverage must provide verification of coverage to the other party, and ORS, if they are involved.
- h. If there is any change in coverage, within 30 days of the change the party ordered to maintain coverage must notify the other party and ORS, if they are involved.
