The court decrees:

Divorce

1. Jonny Barajas Leon is granted a divorce based on the Declaration of Jurisdiction and Grounds signed by Jonny Barajas Leon. The divorce will become final upon entry of the divorce decree.

8. The parties will sign all documents necessary to comply with the divorce decree within 60 days from entry of the decree. If a party fails to sign a document within 60 days, the other party may ask the court to appoint someone to sign the document. (Utah Rule of Civil Procedure 70)

Name after divorce

9. **Miranda Okelani Barajas** changed her name when the parties married. **Miranda Okelani Barajas's** name will be **Miranda Okelani Avila Ramos** after the divorce. Judge's signature may instead appear at the top of the first page of this document.
