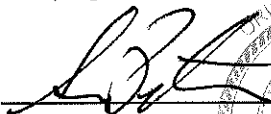
11. **angela ruth ortiz** changed her name when the parties married. **angela ruth ortiz's** name will be **Angela ruth goodell** after the divorce.
