DECREE OF DIVORCE

This matter comes before the court for final entry of the Decree of Divorce. The Stipulation of the parties was signed May 15, 2026, and previously filed. The Court having reviewed the Stipulation and having previously entered its Findings of Facts and Conclusions of Law,

IT IS HEREBY ORDERED, ADJUDGED AND DECREED:

1. The bonds of matrimony and the marriage contract heretofore existing by and between the Petitioner and Respondent are hereby dissolved, and the Petitioner is hereby awarded a Decree of Divorce from Respondent on the grounds of irreconcilable differences, said Decree to become absolute and final upon entry by the Court in the Register of Actions.

The Court having reviewed the Stipulation of the parties and the pleadings in this matter and being fully advised in the premises, now makes its Findings of Fact and Conclusions of Law as follows:

FINDINGS OF FACT

JURISDICTION

2. Residency. Petitioner (referred to as “Melissa” hereafter) has been a resident of Utah County for at least three months prior to the filing of this action.

3. Marriage Statistics. Respondent (referred to as “Michael” hereafter) and Melissa were married on December 1, 2018, in Pleasant Grove, Utah.

NO CHILDREN

4. No Children. No children have been born as issue of this marriage, and no children are expected.

ALIMONY

5. Alimony. Pursuant to the parties’ pre-nuptial agreement signed November 30, 2018, neither party is awarded alimony from the other. The parties are each capable of supporting himself and herself; and, therefore, neither is awarded alimony.

PROPERTY

1. Personal Property. During the course of the marriage relationship, the parties have acquired certain personal property. Melissa is awarded all property in the home; provided however, that Michael is awarded personal property indicated below:

2. Michael will take the personal property he is awarded when he moved from the home, which will be done by no later than July 31, 2026. If Melissa determines she wishes to have Michael move out earlier than July 31, 2026, she will pay Michael \$4,000 and he will move out by June 15, 2026.

3. Commencing on the day the Decree of Divorce is entered, each party will pay his or her own car insurance and health insurance.

4. Commencing June 1, 2026, Michael will remove his phone number from Melissa's telephone account. Melissa will pay in full the amount still owing for Michael's purchase of his telephone.

5. Bank/Financial Accounts. Pursuant to the parties' pre-nuptial agreement signed November 30, 2018, the parties are awarded his or her own separate bank accounts.

6. Real Property. Melissa acquired real property located at 10207 South 6300 West, Payson, Utah, with her separate funds. Pursuant to the parties' pre-nuptial agreement signed

November 30, 2018, Melissa is hereby awarded all right, title, and interest in and to the said real property. Michael hereby waives any right, title, or interest he may have in the said real property. Melissa shall accept and assume exclusive responsibility for any and all debt or obligation arising out of the purchase or ownership of said real property.

BUSINESS INTERESTS

7. Business Interests. Pursuant to the parties' pre-nuptial agreement signed November 30, 2018,, Melissa is awarded all right, title, and interest in her premarital business interest known as BlackBerry Farm Puppies.

DEBTS

8. Debts. The parties acquired debts during the marriage. Pursuant to the parties' pre-nuptial agreement signed November 30, 2018, each will assume, and hold the other harmless from liability on, any debt he or she individually incurred. Michael is responsible to pay all of his own student loans.

FINANCIAL ACCOUNTS

9. Retirement. Each party is awarded his or her own retirement accounts, pension funds, or individual retirement accounts, free and clear of any claim by the other party. Even though Melissa understands that she is most likely entitled to ½ of all of Michael's pension account, she hereby specifically waives any right she may have in Michael's pension and Michael's Vanguard account. Each party specifically waives any and all right he or she may have in the other party's retirement-type accounts.

MISCELLANEOUS PROVISIONS

10. Attorney Fees and Litigation Costs. The parties are ordered to assume his or her own respective attorney fees and litigation costs incurred in this action.

11. Former Name. Melissa is to her former name of Melissa Eulale Lee.
12. All Claims. This resolves all claims either party has against the other.
13. Full Disclosure. Each party full understands the estate, income, and liabilities associated with the dissolution of the marital estate. Each party waives the right to receive further disclosure from the other party.
