THIS MATTER was submitted to the Court for entry of a decree of divorce without a hearing, pursuant to Rule 104 of the Utah Rules of Civil Procedure. The Court, having reviewed the parties' settlement agreement and finding that the provisions of the settlement agreement are fair and equitable, made findings of fact and entered conclusions of law. Based upon its findings of fact and conclusions of law, the Court now:

ORDERS, ADJUDGES, AND DECREES as follows:

- DIVORCE.** Petitioner Maria Fernanda Virgo is awarded a divorce from Respondent Mark James Virgo on the grounds of irreconcilable differences. The bonds of matrimony heretofore existing between Petitioner and Respondent are severed.

2. **CHILDREN.** No children were born as issue of the parties' marriage, and none are expected.
3. **ALIMONY.** The parties are capable of their own support, and no alimony is awarded to either party.
4. **DEBTS.** Respondent shall be solely responsible for the \$10,000 consolidation loan, which is in his name. Petitioner shall pay Respondent \$1,500 as a contribution toward this loan.
5. Any debts incurred after the parties' separation shall be the sole responsibility of the party incurring the debt.
6. The parties shall each hold the other harmless from any liability or damage arising from the debts allocated between them herein, or any debts incurred in their own names.
7. **VEHICLES.** Petitioner is awarded the Mercedes and shall pay Respondent an amount sufficient to satisfy the outstanding loan balance on the vehicle, which she believes to be approximately \$6,000. Respondent shall retain the truck and, within 30 days of executing the settlement agreement, shall refinance the loan to remove Petitioner from any obligation associated therewith.
8. **PERSONAL PROPERTY.** The personal property has been divided, and it is awarded between the parties as presently divided.
9. All personal property acquired prior to the marriage shall remain the property of the party that owns it.
10. **REAL PROPERTY.** The parties own no real property.
11. **TAXES.** For 2025 and all years thereafter, the parties shall file separate tax returns.

12. INVESTMENT AND RETIREMENT ACCOUNTS. There are no investment or retirement accounts that are part of the marital estate.

13. BANK ACCOUNTS. Any joint accounts shall be closed and the funds on deposit shall be evenly divided between the parties. The parties are awarded any accounts in their own names.

14. CONSENTS AND CONVEYANCES. The parties shall execute such assignments, deeds, bills of sale, or other documents as may be necessary and appropriate to carry out the provisions of the decree of divorce entered in this case.

15. NON-VEXING OR HARASSING. Both parties are mutually restrained from attempting, threatening, or committing domestic violence against the other party, this includes stalking, harassing, or physically harming the other party.

16. SURNAME. Petitioner is restored to her maiden name, Maria Fernanda Flores Monroy.

17. ATTORNEY'S FEES. The parties shall each pay their own attorney's fees incurred in this case, if any.
