Divorce

8. The parties will adhere to the following additional provisions:

a.

Additional Provision: We have reached an agreement to file jointly. Exact dates that previous divorces were final are unknown. Date of 4/1/2014 listed for Angelia and date of 3/15/2017 listed for Steven are "on or around" dates. Date of 8/16/2024 listed for Steven and Angelia's separation is a "on or around date." Any assets in Steven's possession will belong to Steven. Any assets in Angelia's possession will belong to Angelia. Aside from what is already described, any debts of Steven's will belong to Steven and any debts of Angelia's will belong to Angelia. There are no children from this marriage. We lived together married from May 2021 to August 2024 and have been separated from August 2024 to current. This divorce and agreement stated here is uncontested.

Duty to sign documents

9. The parties will sign all documents necessary to comply with the divorce decree

within 60 days from entry of the decree. If a party fails to sign a document within 60 days, the other party may ask the court to appoint someone to sign the document. (Utah Rule of Civil Procedure 70)

10. **Angelia Shumway Jeffers** changed her name when the parties married. **Angelia Shumway Jeffers's** name will be **Angelia Shumway** after the divorce.
