DEFAULT JUDGMENT

The Court, having previously entered an order granting Plaintiff's motion for default judgment, hereby enters default judgment against Defendants, Everyday Outdoor Solutions LLC d/b/a Everyday Outdoor Solutions, and Tyler Moss. It is hereby ORDERED and ADJUDGED that:

1. Plaintiff shall recover from Defendants the sum of \$41,125.42 in actual damages, plus late fees in the amount of \$800.00.

2. Plaintiff shall recover prejudgment interest calculated at a rate of 10% per annum July 31, 2020 until June 05, 2026 in the amount of \$23,954.15.
3. Plaintiff is granted the right to immediate possession of the collateral, and Defendants are ordered to immediately turn over the collateral to Plaintiff.
4. Defendants shall pay the total sum of \$65,879.57 to Plaintiff.
5. The total sum of \$65,879.57 claimed in this Judgment does not include any collection costs, litigation costs, or attorney's fees.
6. The Judgment may accrue 5.51% post-judgment interest at the statutory rate set forth in Utah Code §15-1-4.
7. The Judgment may be augmented to include after accruing costs expended in the collection of said Judgment subject to court approval.

It is further ORDERED, ADJUDGED AND DECREED that pursuant to the parties' written agreement, Plaintiff holds a valid security interest in the following property of Everyday Outdoor Solutions LLC d/b/a Everyday Outdoor Solutions, and Tyler Moss: in any and all assets of Everyday Outdoor Solutions LLC d/b/a Everyday Outdoor Solutions, and Tyler Moss, wherever found, that Everyday Outdoor Solutions LLC d/b/a Everyday Outdoor Solutions, and Tyler Moss now owns or shall acquire, including, but not limited to: (a) all tangible and intangible personal property of Defendants, including, but not limited to, all cash or cash equivalents, accounts, deposit accounts, chattel paper, documents, equipment, general intangibles, instruments, inventory, investment property (including certificated and uncertificated securities, securities accounts, securities entitlements, commodity contracts and commodity

accounts), letter of credit rights, commercial tort claims and as-extracted collateral (as those terms are defined in Article 9 of the Uniform Commercial Code (“UCC”) in effect from time-to-time in the State of Utah); (b) all patents, patent applications, trademarks, trade names, service marks, logos, copyrights, and other sources of business identifiers, and all registrations, recordings and applications with the U.S. Patent and Trademark Office (“USPTO”) and U.S. Copyright Office and all renewals, reissues and extensions thereof (collectively “IP”), together with any written agreement granting any right to use any IP; and (c) all accessions, attachments, accessories, parts, supplies and replacements, products, proceeds and collections with respect to the items described in (a) and (b) above, as those terms are defined in Article 9 of the UCC and all records and data relating thereto. Accordingly, the Defendants, Everyday Outdoor Solutions LLC d/b/a Everyday Outdoor Solutions, and Tyler Moss, are ordered to immediately surrender and turn over to the Plaintiff and its representatives, to partially or wholly satisfy this Judgment, all assets that were used to secure the Defendants’ obligations under the Agreement, including those described above. In addition, Plaintiff is entitled to obtain possession of and to liquidate all the assets described above to wholly or partially satisfy this Judgment consistent with the UCC and state law.
