- 24.** Alimony not paid by the 5th of the month is past due on the 6th day of the month. Alimony not paid by the 20th day of the month is past due on the 21st day of the month. If the Office of Recovery services is used to collect child support then ORS may also collect alimony and their payment schedule will be followed.
- 25.** **Alfredo Casiano Cabral De los Santos's** alimony obligation will end the earliest of the following:
- **2** years and **9** months.
 - If **Mayra Birmania Guaman** dies.

- If **Mayra Birmania Guaman** remarries.
- If **Mayra Birmania Guaman** chabits. Cohabitation must be proven in court before **Alfredo Casiano Cabral De los Santos** stops paying alimony.

Retirement money

- 26.** The parties do not need a court order about retirement money.

Duty to sign documents

- 27.** The parties will sign all documents necessary to comply with the divorce decree within 60 days from entry of the decree. If a party fails to sign a document within 60 days, the other party may ask the court to appoint someone to sign the document. (Utah Rule of Civil Procedure 70) Judge's signature may instead appear at the top of the first page of this document.
