The Court has reviewed said declaration, along with the Parties' *Stipulated Settlement Agreement*. The Court has also reviewed all other necessary documents on file in this matter, including the *Acceptance of Service, Appearance, Consent and Waiver*, wherein La'el Howard agreed to her default being entered and to the Court granting a divorce consistent with the terms of the parties' *Stipulated Settlement Agreement*.

The Court, being fully advised in the premises, and for good cause appearing, having previously entered its written *Findings of Fact and Conclusions of Law*,

**NOW, THEREFORE,
IT IS HEREBY ORDERED, ADJUDGED AND DECREE:**

1. Divorce. Petitioner is awarded a Decree of Divorce on the grounds of irreconcilable differences, and the marriage between the Petitioner and Respondent is hereby dissolved. The parties are hereby free and absolutely released from the bonds of matrimony and all obligations thereof with said Decree to become final upon signing and entry.
2. Alimony. Alimony is ordered to be resolved and paid consistent with the *Stipulated Settlement Agreement*, signed by the parties, and ordered in the *Findings of Fact and Conclusions of Law*.
3. Property Division. The property and liabilities of the parties and all other issues between the parties are ordered to be resolved and paid consistent with the *Stipulated Settlement Agreement* signed by the parties, and ordered in the *Findings of Fact and Conclusions of Law*
4. Miscellaneous. The parties are ordered to execute and deliver all documents necessary to effectuate this Decree of Divorce.
