The court decrees:

## Divorce

1. Lanny Gale Ross is granted a divorce based on the Declaration of Jurisdiction and Grounds signed by Lanny Gale Ross. The divorce will become final upon entry of the divorce decree.

Children (Utah Code 81-6-101(7))

2. **Lanny Gale Ross** and **Jeraldine Marie Ross** do not have any children together.

- We do not have any children together who are minors. A minor is a child under 18 who has not been married or otherwise emancipated.
- We are not expecting a child.
- We do not have incapacitated adult children together who are eligible for child support, or, **Lanny Gale Ross** is not asking for child support for any adult child who is eligible for child support.

### Personal property (Utah Code Title 81, Chapters 1, 4, 6, and 9)

3. All personal property not addressed in the divorce should be divided as the parties have already divided it.

### Debts

4. The parties are not aware of any debts from the marriage. If any debts exist, each debt will be the responsibility of the party who incurred the debt.

### Real property

5. The parties do not have any real property that is marital property. The parties do not need a court order about real property.

### Alimony

6. Neither party will pay alimony.

### Retirement money

7. The parties do not need a court order about retirement money.

### Additional provisions

8. The parties will adhere to the following additional provisions:

a.

**Additional Provision: The parties agree that no alimony shall be awarded to either party, and both parties permanently waive any right to receive alimony now or in the future.**

b.

**Additional Provision: Each party shall be solely responsible for any debts incurred in their own name and shall hold the other party harmless from those debts. Neither party shall be responsible for the other party's individual debts or financial obligations.**

### Duty to sign documents

9. The parties will sign all documents necessary to comply with the divorce decree within 60 days from entry of the decree. If a party fails to sign a document within 60 days, the other party may ask the court to appoint someone to sign the document. (Utah Rule of Civil Procedure 70)
