The matter is before the court on Petitioner’s *Motion to Enforce Decree of Divorce* (April 20, 2026). Petitioner was awarded her reasonable attorney fees on April 20, 2026 during the Motion to Enforce hearing before Honorable Commissioner Marla Snow. Petitioner filed an Affidavit of Attorney Fees regarding her reasonable attorney fees incurred relating to the Motion to Enforce on May 29 2026. Over seven (7) days have passed, and Respondent has not filed an Objection to Petitioner’s Affidavit of Attorney Fees. Therefore, a judgment shall enter the claimed amount pursuant to URCP 73(d).

Having considered the filings, the court **ORDERS:**

1. Petitioner is awarded her reasonable attorney fees in the amount of **\$12,824.50.**
2. Petitioner is awarded a money judgment against Respondent for attorney fees in the amount of **12,824.50** plus post judgment interest of 3.51% per annum to begin the date of this order.
