The court decrees:

Divorce

Additional Provision: Except as otherwise expressly provided in this Stipulation, each party is awarded and shall retain as his or her sole and separate property all personal property currently in that party's possession. Except as otherwise expressly provided in this Stipulation, each party shall retain any asset titled solely in that party's name and shall be solely responsible for any debt or obligation incurred solely in that party's name, and shall indemnify and hold the other party harmless from the same.

Duty to sign documents

9. The parties will sign all documents necessary to comply with the divorce decree within 60 days from entry of the decree. If a party fails to sign a document within 60 days,

the other party may ask the court to appoint someone to sign the document. (Utah Rule of Civil Procedure 70)
