Respondent, Rachel Ruth Piccolo Moises, hereby submits this Proposed Decree of Divorce pursuant to the Court's Order and Memorandum Decision entered on April 1, 2026.

I. FINDINGS

1. The parties were married on November 22, 2003.
2. The parties have experienced irreconcilable differences, and the marriage is irretrievably broken.
3. On April 1, 2026, this Court entered an Order granting Respondent's Motion to Bifurcate and directing that a Decree of Divorce be entered dissolving the marriage, with all remaining issues reserved for trial or further order of the Court.

C. Reservation of All Remaining Issues

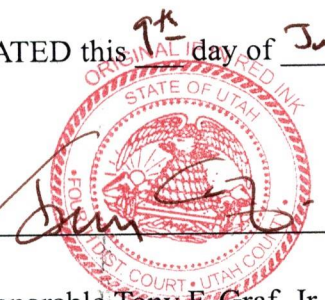
All remaining issues in this matter are hereby expressly reserved for trial or further order of the Court, including but not limited to:
