The above-entitled matter came before the Court upon Petitioner's Verified Motion to Bifurcate Divorce. The Court, having reviewed the Motion, the court file, and being otherwise fully advised in the premises, hereby enters the Bifurcated Decree of Divorce, as follows:

IT IS HEREBY ORDERED, ADJUDGED, AND DECREED that:

1. The marriage between Petitioner Morgan Szendre and Respondent Joseph Szendre is dissolved pursuant to Utah Code Ann. § 81-4-405(1)(h), and the parties are hereby divorced.
2. All remaining issues are expressly reserved for trial and future determination by the Court, including but not limited to:

- a. Legal custody;

- b. Physical custody;
- c. Parent-time;
- d. Child support;
- e. Alimony;
- f. Division of marital property;
- g. Allocation of marital debts;
- h. Attorney fees and costs; and
- i. Any other claims, defenses, requests for relief, or issues raised by the pleadings.

3. No findings or determinations are made herein regarding any issue reserved for future adjudication.

4. All temporary orders, recommendations adopted by the Court, and prior orders entered in this action shall remain in full force and effect unless modified by further order of the Court.

5. The Court retains continuing jurisdiction over this matter for purposes of resolving all reserved issues and entering a Final Supplemental Decree addressing those issues.
