Duty to sign documents

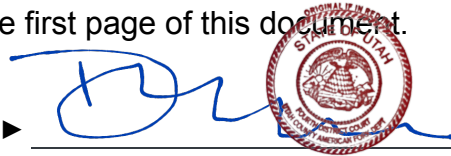
