Divorce

a.

Additional Provision: Starting April 1st, 2026, Nicolas Orrego will pay Megan Jolley \$1,100 of rent by the fifth of the month for April and May; and then 600\$ in June. Megan Jolley will provide assistance if required for immigration status filing with USCIS.

Duty to sign documents

12. The parties will sign all documents necessary to comply with the divorce decree within 60 days from entry of the decree. If a party fails to sign a document within 60 days, the other party may ask the court to appoint someone to sign the document. (Utah Rule of Civil Procedure 70)
