Steven McCartney is to keep everything he took from their home at the time of him moving out on 3/9/2026, including but not limited to, his wedding ring, appliances removed from the apartment, including the juicer and the Soda Stream, his MacBook Pro, his iPad, video games and associated consoles.

Debts

7. The parties are not aware of any debts from the marriage. If any debts exist, each debt will be the responsibility of the party who incurred the debt.

Real property

8. The parties do not have any real property that is marital property. The parties do not need a court order about real property.

Alimony

9. Neither party will pay alimony.

Retirement money

10. The parties do not need a court order about retirement money.

Additional provisions

11. The parties will adhere to the following additional provisions:

a.

Additional Provision: 1. For various bills, it is agreed upon that Steven owes Michelle \$232.18. Michelle owes Steven \$131.93. It has also been agreed upon that both parties will be equally splitting the filing fee. Parties have agreed that Steven will pay Michelle the difference of \$100.25 and his half of the filing fee (\$176.50) in three separate payments of \$92.25 every Wednesday following filing with the court. The total payment will be \$276.75. 2. Tax Installment Agreement. For tax year 2024, the parties entered into an installment agreement to pay amounts owed to the IRS. The current payment on the installment agreement is \$50 per month and payments are due on the 28th of each month. Both parties will be paying the IRS their half of the payment individually, until the IRS can split the debt fairly. 3. Mutual Restraining Order. Both parties are mutually restrained from harassing, annoying, or otherwise bothering the other party. Neither party will use the other party's likeness, picture, name, identity, identification, or credit to obtain credit, open an account for any service, obtain any other service, or for any other purpose. 4. Financial Accounts. The parties should be awarded any and all premarital bank accounts, respectively, free and clear of any claim from the other party. During the marriage, each person maintained their own separate bank accounts and only utilized shared accounts for the purpose of paying bills. The Canyon View Credit Union shared account has been closed as agreed to by the parties. The America First Credit Union shared accounts have less than ten cents in total and can be closed by either of the parties. 5. The Financial Disclosure requirements in Utah Rules of Civil Procedure Rule 26.1 are applicable to both Respondent and Petitioner but should be waived upon the signing of this Petition by the parties. Each party is satisfied with the information he or she has regarding the other party and waives all rights to disclosures or discovery. 6. Apartment Lease. The parties signed a lease to rent an apartment in Saratoga Springs, Utah through February 2027. The Petitioner has opted to remain in the apartment and assume responsibility for maintaining the rent, all utilities, and any other costs to maintain the lease. Respondent vacated the apartment on March 9, 2026. Both parties have signed the Settlement Agreement Release of Resident Agreement with the landlord. 7. Respondent's Legal Name. Respondent's current legal name is Steven Maxwell McCartney. Respondent legally changed his name from Steven Maxwell Kinard to Steven Maxwell McCartney pursuant to the Order Granting Name Change entered by the Superior Court of California, County of Placer, Case No. SCV0038389, on

November 14, 2016. Respondent previously used the legal name Steven Maxwell Kinard at the time he met Petitioner, prior to the marriage. All references in this Stipulation and Decree to Respondent shall refer to Steven Maxwell McCartney, formerly known as Steven Maxwell Kinard.

Duty to sign documents

12. The parties will sign all documents necessary to comply with the divorce decree within 60 days from entry of the decree. If a party fails to sign a document within 60 days, the other party may ask the court to appoint someone to sign the document. (Utah Rule of Civil Procedure 70)
