The Court, having previously entered its Order on Petitioner’s Motion to Enforce Order and for Sanctions from the hearing held May 5, 2026, hereby ORDERS, ADJUDGES and DECREES as follows:

1. Judgment is hereby entered in favor Petitioner Christine Marble and against Respondent

Dustin Marble for arrearages, costs and attorney fees in the total amount of \$24,489.47 (the **“Total Judgment Amount”**) as follows:

- (a) Child support arrearages through May 2, 2026 in the amount of \$11,767.98;
 - (b) Alimony arrearages in the amount of \$6,587.00 through August 7, 2025;
 - (c) Child medical insurance and child medical out-of-pocket expenses through May 2026 in the amount of \$799.49;
 - (d) Petitioner’s costs and attorney fees through May 8, 2026 in the amount of \$5,335.00.
2. This Judgment shall bear interest on the Total Judgment Amount beginning May 22, 2026, pursuant to Utah Code §15-1-14, at the annual rate of 5.70% until paid in full.
3. This Judgment may be augmented upon proper application by Petitioner for costs and attorney fees incurred in collecting the total judgment amount.
4. This Judgment is final pursuant to Utah Rules of Civil Procedure 54(b) as there is no just reason for delay.
