This matter comes before the Court on Petitioner's Petition for Divorce. A final resolution of the matter was reached by agreement as reflected in the Stipulation and Settlement Agreement, signed by the parties. After reviewing the pleadings on file in this matter, and having been fully advised in the premises herein, the Court makes the following:

FINDINGS OF FACT

1. The parties are bona fide residents of Utah County now and for at least three months prior to the commencement of this action.

2. The parties are husband and wife having been married on August 9, 2013. Kenneth and Terry have been living separate and apart since December 1, 2024.
3. Irreconcilable differences have arisen, making the continuation of the marriage no longer feasible.
4. There are no minor children as issue of this marriage, and none have been adopted.
5. The parties have reached an agreement which resolves all issues in the above-captioned action.
6. The terms of the agreement are fair, just, and equitable.

CONCLUSIONS OF LAW

7. This court has jurisdiction over the parties and the subject-matter in this case, and the parties are entitled to a Decree of Divorce.
8. The parties should be awarded a divorce one from the other on the grounds of irreconcilable differences, the same to become final and absolute upon entry by the court.
9. The Decree of Divorce shall incorporate the terms of the Stipulation and Settlement Agreement.
