On March 9, 2026, the court awarded Respondent her fees incurred in bringing and litigating her motion to enforce.

1. The Petitioner incurred fees of \$780 in drafting the response to the motion to enforce. See Affidavit of Spencer Thomas
2. The Petitioner incurred fees of \$570 in drafting the counter motion to enforce.
3. The Petitioner incurred fees of \$330 in attending the first hearing, and preparation for the hearing.
4. The Petitioner incurred fees of \$570 putting together updated spread sheet

showing child support/alimony calculation and responding to opposing parties' child support/alimony calculation.

5. The Petitioner incurred fees of \$150 for attending a hearing on March 3, 2026 that had to be continued because the children were in Respondent's car.

6. The Petitioner incurred fees of \$150 for the hearing on March 9, 2026.

7. In total, the Petitioner incurred fees of \$2550 in bringing and litigating Respondent's motion to enforce and her counter motion to enforce.

8. Judgment should be entered against the Respondent Kaleb Winters, in favor of Petitioner Sienna Powers, in the amount of \$2550 together with accruing interest.
